FINAL AND UNCONDITIONAL RELEASE OF LIABILITY AND ACCEPTANCE OF RISKS OF THE NATIONAL YOUTH HUNTING ASSOCIATION (NYHA).

I have knowingly and willingly entered into an NYHA Youth Activity and agree to abide by its rules, terms, provisions and conditions. I understand that if any member of my child's hunting party displays unsafe, unethical, illegal or disruptive actions/attitudes or disobeys rules/policies, the entire party may be removed from the activity at the sole discretion of the Huntmaster, land owner or NYHA Representative in charge, as they have absolute authority over the entire activity. In the event that photographs, slides, interviews or video tapes are made of any minor child, I consent to the release of those images for use by the NYHA.

IN CONSIDERATION FOR THE RIGHT TO PARTICIPATE IN THE NYHA ACTIVITY, I UNCONDITIONALLY RELEASE, INDEMNIFY AND HOLD HARMLESS:

National Youth Hunting Association AND ALL OF THEIR OFFICERS, DIRECTORS, TRUSTEES, EMPLOYEES, VOLUNTEERS, AGENTS, REPRESENTATIVES AND COLLECTIVELY ("RELEASED PARTIES") FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION AND DAMAGES, INCLUDING ATTORNEY'S FEES FOR PERSONAL INJURY OR LOSS EITHER AT OR EN ROUTE TO AND/OR FROM THE NYHA ACTIVITY, RESULTING IN ANY ACCIDENT, INCIDENT OR OCCURANCE ARISING OUT OF, INCIDENTAL TO OR IN ANY WAY RESULTING FROM ANY WAY RESULTING FROM, THE NYHA ACTIVITY WHETHER OR NOT CAUSED BY ANY RELEASED PARTY'S NEGLIGENCE OR GROSS NEGLIGENCE. I AGREE THAT I, MY HEIRS, SUCCESSORS AND ASSIGNS WILL NOT MAKE ANY CLAIM OR INSTITUTE ANY SUIT AGAINST THE RELEASED PARTIES. **THIS RELEASE IS FULL, FINAL AND UNCONDITIONAL, AND IS GIVEN FOR GOOD AND VALUABLE CONSIDERATION. BUT FOR THIS RELEASE, THE NAMED CHILD OR I WOULD NOT BE ALLOWED TO PARTICIPATE IN THE NYHA ACTIVITY. THIS RELEASE IS INTENDED, AND SHALL BE CONSTRUED, TO EXCLUDE THE RELEASED PARTIES FROM ANY AND ALL LIABILITY.**

I further acknowledge and understand that no warranty, either expressed nor implied, is made by NYHA as to the NYHA activity, or of any roads, buildings, gates, or other improvements, and that dangerous conditions, risks and hazards do exist, including but not limited to poisonous snakes, insects, spiders, blinds and tree stands, whether or not erected by the participant(s); erosion and general conditions of the land, both on and off roadways or trails, creating rough, hazardous and dangerous driving and walking conditions; animals both wild and domestic that may be diseased and/or potentially dangerous; deep water, persons with firearms and knives; and the use of any type of vehicle(s). I am aware of these conditions and expressly assume all dangers, risks and hazards.

I give permission to have emergency first-aid administered in the sole discretion of the Huntmaster, or NYHA representative to be transported by the most expedient means of conveyance to the nearest physician, hospital or clinic and to there receive any such treatment as is medically prescribed by the physician(s) and/or medical staff. If I do not accompany any minor child at the NYHA activity, I authorize _____ to serve as the child's appointed guardian during the NYHA activity.

Unless assistance is requested prior to the hunt, I assume responsibility for the properly identifying of any animal(s) to be harvested. I will pay restitution for any unauthorized game that is harvested by the named hunter/child for this event.

As used in this release, the terms *I*, *my person* and *myself*, applies regardless of the nature of my involvement with the NYHA, and whether or not I attend any NYHA activity, accompany a minor child, serve as a volunteer, or otherwise, and includes to the maximum extent permitted by law any minor children participating in any NYHA activity.
